The commission approved the variance request. A sign permit was issued.
- 2. Variance request of Section 152.232 A (4) to allow a sign to be at a height of 11 feet above adjacent grade instead of the required 10 foot height in a B2, general business zoning district, located at 2506 Volunteer Dr, PIN #95-35-352-002. The

Commission approved the variance request. A sign permit was issued February 8, 2017.

Development Ordinance to allow a setback 25 foot 6 inch rear yard setback instead of the required 30' setback, located at 3293
