Single Family & Two Family Residential Electrical Permit Fees.

- New single family and two family residences (except electric heat, temporary service and permanent service), per residential unit - \$40.00
- Electric heat in single-family and two-family residences (baseboard), per residential unit - \$20.00
- Incidental units (air conditioning units, electric water heaters, electric ranges, dishwashers, disposal units, electric clothes dryers, washing machines, microwaves, furnaces, electric motors, adding incidental outlets - for each five outlets or part thereof, and items not otherwise listed), per unit - \$10.00
- Signs, per unit - \$10.00
- Temporary service, per unit - \$10.00
- Permanent service (single-family and two-family residences), per meter or un-metered opening - \$20.00
Each additional meter opening - \$5.00
- Room additions or rewiring of existing rooms, per room - \$10.00
- Detached garages - \$15.00
- Pool, generator, and hot tub - \$15.00

Multi-Family, Institutional, Commercial, & Industrial Permit Fees.

- First \$1,000.00 cost or contract bid - \$15.00
- Each additional \$1,000.00 or fraction thereof - \$5.00

Required Inspections.

- Underground Rough-In (prior to any back fill so all wiring, conduit and fittings are exposed and visible)
- Interior Rough-In (prior to any drywall or wall covering so all conduit, wiring and boxes are exposed and visible)
- Final Inspection (after all electrical devices and fixtures are set and complete)

ALL PERMITS REQUIRE INSPECTIONS TO BE SCHEDULED BY PERMIT HOLDER.
