TYPICAL SIGN MEASUREMENTS	
Sign setback is the minimum horizontal distance between the property line and any portion of the sign.	
Sign area is measured by the smallest square, rectangle, circle or combination thereof that encompasses the entire sign facing.	
	
Sign area = A * B	
	
Sign area = (A*B) + (C*D)

IF YOU DO NOT PROVIDE ALL THE REQUIRED INFORMATION YOUR PERMIT WILL NOT BE ACCEPTED.

Requirements for all signs

- _____ A scaled site plan showing all lot dimensions, adjacent roads, public right of way, buildings, points of ingress, parking areas and where the sign(s) will be located on the property with setbacks from the closest portion of the sign to property lines and easements. If the property is a corner lot, site plan must show the area within the 30 foot triangle.
- _____ Indicate whether the proposed sign(s) are new installations or a new sign on existing supports.
- _____ Indicate the Zoning District of the property and if it is in the Special Service Area or a Historic District.
- _____ Accurate depiction/elevation of sign(s) showing the total height from grade, dimensions (width, height), total square footage, shape, material, color(s), message and number of faces (single or double).
- _____ Dimensions, description and location of all existing signs on the property that will remain after the new sign(s) are installed.
- _____ If the sign will be illuminated, **a separate permit must be issued for electrical service to sign.**

On-Premise Ground, Pole, Pylon and Monument Signs (in addition to requirements for all signs)

- _____ Accurately show on site plan any off-premise signs within 75 ft of proposed sign location.
- _____ Elevation showing the height of the tallest part of sign and measurement of the lowest part of the sign to grade.
- _____ Footing diagram with dimensions

Awning, Canopy, Marquee, Projecting, Wall and Roof signs (in addition to requirements for all signs)

- _____ Indicate whether the structure to which the sign is to be attached is a Local Historical Landmark.
- _____ Accurate depiction of where sign will be located on building, height of the tallest part of sign, measurement of the lowest part of the sign to grade and how far sign will project from and/or above the building.
- _____ Elevation of the wall(s) to which the sign(s) will be attached showing width, height, openings and any existing signs on the wall and/or roof. If a multi-tenant building, also show width and height of wall for each tenant space.
- _____ Mounting method (how is this sign being attached to wall/roof). Specify hardware to be used.

Off-premise signs only allowed in B-1, B-2, B-3, M, M-1 or M-2 (in addition to requirements for all signs)

- _____ Depiction of sign should show, with dimensions, whether the sign is Back-to-Back, V-Type or Single Faced
- _____ Indicate whether the sign is within 750 ft (lineally) of another off-premise sign or within 75 ft, (radially) of an on-premise sign
- _____ Indicate, in feet, the distance the sign is to a Residential Zoning District and also from any park, playground, church or school
- _____ Indicate proposed hours of illumination
- _____ Copy of lease agreement (if applicable).
- _____ Structural calculations
- _____ Footing diagram with dimensions

Directory Signs only allowed in B-1, B-2, B-3, CPD, M, M-1 or M-2 (in addition to requirements for all signs)

- _____ Indicate whether property is a business park, industrial park or regional shopping center that has >30 acres and at least one anchor store with >100,000 sq ft of retail area.
- _____ Provide a copy of the recorded easement authorizing the installation of a sign.
- _____ Footing diagram with dimensions

Highway Identification Pole Signs, only allowed in B-2 or CPD (in addition to requirements for all signs)

- _____ Site plan must show the entire property is within 1,500 ft of the centerline of I-74 or US Hwy 34.
- _____ Indicate the total size of the lot (must be > 1 acre).
- _____ Indicate, in writing, the business is tourist traveler oriented (e.g. hotel, motel, gas station, truck stop and fast food)
- _____ Footing diagram with dimensions
